Instructions to Bidders (ISB)

<u>Disposal of Old/Unusable/Obsolete Computer Hardware, Peripherals, lying at</u> <u>Branches/ Offices of Andhra Pragathi Gramenna Bank.</u>

1. Introduction:

Andhra Pragathi Grameena Bank, intends to dispose old/unusable/obsolete Computer Hardware, Peripherals, etc. (identified by Bank), lying at different branches. For this, sealed price quotations are invited from the Empaneled vendors for participation in the Tender process.

2. Scope of Work:

Scope includes collecting & purchasing various Hardware items (identified by the Bank for disposal) from our branch premises on "as is where is location basis" for disposal/recycling/reusing in line with Central/State Government guidelines.

3. Eligibility Criteria:

- 3.1. The bidders should hold valid Certificate from State Pollution Control Board/Govt. Authorities for undertaking E-Waste Disposal as on the date of FA bid in GeM. The copy of the certificate should be submitted along with the bid.
- 3.2. The bidders quoting for this bid should agree to the condition to "remove the storage media viz., Hard disk, Tapes, DATs, etc. and the same has to be degaussed in front of the Concerned Bank officials before lifting the E- Waste from the Various locations of the Bank".

OR Bidders need to break the Hard disk in front of the Bank officials.

3.3. The bidders need to submit an undertaking that all the e-waste items, as proposed by Andhra Pragathi Grameena Bank for disposal will be disposed off as per e- waste disposal guidelines of State / Central government authorities.

4. Documents to be uploaded in GeM:

- 4.1. The response to this GEM forward auction will be submitted by scanning the documents as detailed below:
 - 4.1.1. Bid documents:
 - (a) Bid Covering Letter as per Annexure-A.
 - (b) Central / State Govt. Pollution Control Board certificate valid till date of FA (Forward Auction) in GeM.
 - (c) EMD by way of DD favoring Andhra Pragathi Grameena Bank, payable at Kadapa.
 - (d) PAN Copy of the Company.

5. Terms & Conditions:

- 5.1. The bid is non-transferable.
- 5.2. EMD amount and documents under point 4 has to be submitted before opening of the bid and follow the schedule as per Forward Auction in GeM.
- 5.3. Price Schedule (Commercial Offer) is as per the GeM portal.
- 5.4. The bidders may inspect the items on or before 05.03.2025 01:00 PM and satisfy themselves about the items for which they are bidding for. The locations details where the E-Waste can be inspected mentioned in the Annexure-B.
- 5.5. Scrap Items are to be taken from the various branch/office premises and locations as referred in Annexure-C by the successful Vendor.
- 5.6. The status of the e-waste items proposed to scrap is mentioned in Annexure-D.
- 5.7. The bidder shall bear for all the costs associated with the preparation and submission of its bid, and Andhra Pragathi Grameena Bank in no case will be responsible or liable for these costs, regardless of conduct or outcome of bidding process.
- 5.8. All expenses pertaining to collecting, transporting for disposal (as per govt. guidelines), is to be borne by the successful bidder.
- 5.9. Item shall be sold to the bidder with highest bid price.
- 5.10. The successful bidder has to remit the total amount quoted in the bid by way of Demand Draft/RTGS favoring Andhra Pragathi Grameena Bank and send it to our Office within 05 Working days of intimation of being H1 Bidder.
- 5.11. The Successful bidder has to lift all the items from disposal site within 15 days after issuance of Order. On failure to do so, Andhra Pragathi Grameena Bank, Department of IT shall have the right to forfeit the entire EMD remitted and Bank may dispose the items through H2/H3 Bidders.
- 5.12. The Successful bidder to comply and ensure with the Tender Clause on degaussing of data as referred in Clause (3.2) above.
- 5.13. The Bank reserves the right to accept or reject any price quotation or

cancel the disposal process and reject all quotations at any time, without thereby incurring any liability to the affected bidders or any obligation to inform the bidders of the ground for the Bank's action. The bidders may on their own interest contact the Bank on the status of the tender after opening of the bids.

- 5.14. Once the Hardware items are handed over to the successful bidder, the same shall not be taken back by the Bank.
- 5.15. All the required documents to transport the E-Waste from Banks various locations to bidder's location (complying with the Govt. Guidelines), will be arranged from the bidder's side. Bank will only give the required declaration.
- 5.16. All documents must be duly signed by the authorized signatory of the bidder. No overwriting, erasures are permitted.
- 5.17. After the auction process in the Gem portal is completed, the H1 bidder has an option to pay the amount for lifting the scrap in single instalment or Bidder can opt for two instalments for lifting total scrap of the Bank. The same need to approve by the Bank.
- 5.18. Region wise scrap details of all units will be shared to H1 bidder upon successful completion of auction process.

6. Amendment to Bidding Document:

- 6.1. At any time prior to deadline for submission of Bids in GeM, the Bank for any reason, whether, at its own initiative or in response to a clarification requested by prospective empaneled bidder, may modify the bidding document, by amendment.
- 6.2. In order to allow reasonable time to prospective bidders to take the amendment into account in preparing their bids, the Bank, at its discretion, may extend the due date for submission of bid for a reasonable period as decided by the Bank for the submission of bid in GeM.

7. <u>Earnest Money Deposit (EMD):</u>

- 7.1. The bidder shall furnish Earnest Money Deposit (EMD) of Rs.20,000/-(Rupees Twenty Thousand only) by way of Demand Draft drawn on any scheduled bank in favour of Andhra Pragathi Grameena Bank, payable at Kadapa and should be uploaded in GeM. The EMD of the un-successful Bidders will be returned upon the H1 Bidder accepting the order.
- 7.2. MSEs are exempted from submission of EMD. To avail exemption, bidders have to upload the udhyam registration certificate in GeM portal.

7.3. The EMD may be forfeited:

- 7.3.1. If the bidder withdraws or amends the bid during the period of bid validity specified in this document.
- 7.3.2. If the selected bidder fails to accept the order within 5 days in accordance with the terms of the bid.
- 7.3.3. If the H1 bidder fails to lift the E-Waste within 15 days of accepting the order, EMD shall be forfeited and the E-Waste shall be disposed through the next highest bidder/other means.

8. Price Composition:

- 8.1. The price quoted should be only in Indian Rupees.
- 8.2. The bidder has to quote excluding GST as mentioned in the Bill of Material.
- 8.3. The bidders should alone bear the expenses like transportation, loading/unloading/de-grouting/decommissioning of equipment charges etc.

9. Opening of Bids:

9.1. Commercial offer will be opened in GeM as per date/time mentioned in the GeM Bid.

10. Evaluation Criteria:

- 10.1. For Commercial evaluation, total items value is considered i.e.., computer scrap, UPS & Batteries considered as single item. Contract will be awarded to the H1 bidder item wise.
- 10.2. After completing the above process, the Bank will declare H1 Bidder in order to determine the Highest evaluated Bid (H1) and will award the contract to the H1 Bidder. In case of failure or refusal to execute the order, APG Bank, DIT, HO shall have the right to dispose the items to next highest bidder/s on matching the H1 (Highest) prices.


